

ASSESSMENT ORDINANCE NO. MW-2879

AN ORDINANCE LEVYING SPECIAL ASSESSMENTS AGAINST CERTAIN PARCELS OF LAND WITHIN THE CITY OF OVERLAND PARK, JOHNSON COUNTY, KANSAS, IN ORDER TO PAY THE COSTS INCURRED FROM CUTTING WEEDS AND OTHER NOXIOUS GROWTH ON SAID PARCELS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OVERLAND PARK, KANSAS:

SECTION 1. The costs of cutting weeds and noxious vegetation growth and removing trash and refuse from certain lots, pieces, or parcels of land with the City of Overland Park, Kansas, heretofore incurred by the City in compliance with O.P.M.C. Chapter 7.04, O.P.M.C. Chapter 7.20, and O.P.M.C. Chapter 7.26 are hereby declared to be special assessments levied against the following lots, pieces or parcels of land in the following amounts:
